

## Assistance Authorization

In order to facilitate and formalize my participation in the OU-Norman [Open Access policy](#), I hereby expressly authorize the University of Oklahoma (“OU”) Libraries Open Initiatives and Scholarly Communication (“OISC”) department and its designated liaisons (collectively, “OISC”) to assist me in submitting material to OU’s open access repository, SHAREOK™ (the “Repository”). As used herein, the term “Assistants” means the staff members, student employees, and liaisons of the OISC which may be a fellow faculty member, college, school, center, lab, or program. I understand that the Repository submission process involves enabling the OISC to obtain a copy of my material, making choices about access and other matters, and signing a SHAREOK™ distribution license and University Agreement (i.e. a Repository-based license). **I hereby expressly represent and acknowledge that I have reviewed the OISC Agreement below and the information about current OISC procedures for depositing and posting articles in the Repository.** I hereby expressly authorize and grant permission to the OISC and its Assistants to act for me in submitting my Material(s) (Item(s) of research and/or scholarship intended for publication in academic journals) to the Repository, including signing Repository-based agreements on my behalf, and taking any other action for me in connection with the Repository, with the same effect as if I had taken those actions myself. In addition, if I am an OU-Norman faculty and/or a member of an OU-Norman college, school, center, or program that has adopted the OU-Norman open access policy, or opted into an Individual Open Access License, this confirms my grant to OU of a nonexclusive license with respect to my scholarly articles as set forth in that policy.

SHAREOK™ submission requires that authors enter into a simple distribution license regarding the deposit, distribution, and use of the item being submitted.

## SHAREOK™ Distribution License and University Agreement

When you upload your work to the SHAREOK™ digital repository you retain your copyright (unless you have transferred it to someone else). If the work has been previously published and copyright was transferred to the publisher, please check your author rights with each publisher for information on uploading to an institutional repository. In the case of co-authors, all authors must sign a release for inclusion in SHAREOK™.

By submitting your work to SHAREOK™ you (the author(s) and/or copyright owner(s)) (collectively, the “Licensor”) hereby grant the Board of Regents of the University of Oklahoma (“Licensee”) the non-exclusive, royalty-free, worldwide right to reproduce, translate, and

distribute the submission (including any associated abstract) in electronic format on behalf of and in concert with the SHAREOK.org website and digital repository program.

By agreeing to the terms of this license, the Licensor expressly agrees, acknowledges, understands, and warrants the following:

#### **1. Rights Granted to Licensee**

- The Licensee may translate the submission to any medium or format for the purpose of preservation.
- The Licensee may retain multiple copies of the submission for purposes of security, back-up, archiving, and preservation.
- The Licensee may enhance the metadata and revise file names to improve discoverability and adhere to best practices.
- The Licensee will not alter the content of the submission except as explicitly allowed by this license

#### **2. Licensor's Representations and Warranties**

- The submission is the Licensor's original work, or the Licensor has obtained express permission from all applicable third parties to grant the rights outlined in this license.
- Any third-party material included in the submission is clearly identified and attributed.
- To the best of the Licensor's knowledge, the submission does not infringe upon any intellectual property rights, including copyright, of any third party.
- If the submission is the result of sponsored research, the Licensor has fulfilled all rights of review or other applicable obligations required by the sponsorship agreement prior to submission.

#### **3. Rights Granted to Readers**

The Licensor agrees that authorized readers of their submission have the right to use the work for non-commercial, academic purposes, provided that:

- All attributions, including author credits and copyright statements, are retained.
- The work is not altered in any way beyond what is allowed by applicable U.S. copyright law(s).
- Any use beyond the scope of applicable U.S. copyright law(s) requires separate permission from the Licensor or rights holder.

#### **4. Theses and Dissertations**

- In accordance with University policy, theses and dissertations must be made publicly available through SHAREOK™, subject to any applicable embargoes. By agreeing to

this license, the Licensor grants the necessary rights for public distribution via SHAREOK™.
